

# Cookie Policy

**This website collects some Personal Data from its Users. This document can be printed using the print command present in the settings of any browser.**

## What are cookies?

User navigation on the site <https://larotondacamogli.com> it is registered by cookies. Cookies are small "data files", in the form of a unique anonymous code, which are downloaded from the user's browser, allow the analysis of their browsing habits and are treated with the intent to improve the services offered online. After the first visit to the site from your computer or other device, the registration of cookies allows you to recognize that the user has already visited the contents of the site and allows third-party suppliers, including Google, to publish Remarketing and Display ads on sites of the Google Network or of third parties that link to the site <https://larotondacamogli.com>.

## Types of cookies used on this site:

### 1. Technical

cookies These cookies are used to facilitate user navigation, allowing the site to "remember" some choices made. For example, they are used to remember the username and password used to access the personal area. They are not used for other purposes, and are managed directly from the web.

They are divided into:

a) **Navigation and / or session cookies:** they are designed to ensure normal navigation and use of the site. These cookies allow, for example, to store the username and password entered for the personal area and keep them active while browsing from one page to another.

b) **Analytics: these** cookies are cookies that collect information on the number of users and how they visit the site, for example information on which pages or sections of pages are most viewed, and from which pages reports of malfunctions are received. The information is collected in an aggregate and anonymous form;

c) **Functionality** cookies: these are cookies that allow the user to browse according to a series of selected criteria (such as text characters, browser type) in order to improve the service rendered.

### 2. Profiling

cookies We use these cookies to create an anonymous browsing profile that allows us to send targeted communications, to show content and commercial initiatives based on the sections of our sites that are most relevant to the user and his interests. . These cookies, like those above, are managed directly by our company.

It is also possible to disable cookies by changing the settings of your browser, although this website works optimally with all types of cookies enabled.
